**Obligation**

*Shuttle Bus Service for the Elderly and Disabled.* Commencing on May 20, 2009, CU shall provide a shuttle bus service complying with ADA specifications to connect the Project Site to subway stations at 116th Street and Broadway, 125th Street and Broadway, 168th Street and Broadway and Harlem Hospital Center. The shuttle bus service shall be provided free of charge to members of the public who are disabled or who are senior citizens, including their attendants. The shuttle bus service shall run on a regular schedule throughout the day every weekday except State and Federal public holidays. If during this period the IRT subway station located at 96th Street and Broadway is made ADA accessible, CU shall provide shuttle bus service to connect this station to the locations above. The shuttle bus service shall be provided through 2033, but may be discontinued if and when the 125th Street IRT station becomes ADA accessible.

\*The Obligation End Date is December 31, 2033, unless the shuttle bus service for the elderly and disabled is discontinued if and when the 125<sup>th</sup> Street IRT station becomes ADA accessible, per the obligation language above.

SECOND AMENDMENT dated as of July 1, 2017 to the FIRST AMENDMENT DATED AS OF July 1, 2014 to Agreement dated as of July 18, 2011 between THE TRUSTEES OF COLUMBIA UNIVERSITY IN THE CITY OF NEW YORK ("Licensor"), a New York non-profit corporation, having an office at 411 West 116<sup>th</sup> Street, New York, New York, 10027, and Academy Express, LLC, having a principal place of business at 111 Paterson Avenue, Hoboken, NJ 07030 (herein referred to as "Academy or Service Provider").

WITNESSETH:

WHEREAS, Licensor and Academy have entered into an Agreement, dated as of July 18, 2011 and an Amendment, dated as of July 1, 2014 (collectively the "Agreement");

WHEREAS, the Agreement grants to Academy the right to provide non-exclusive shuttle services to the Columbia community;

WHEREAS, Licensor and Academy desire to amend the Agreement as hereinafter set forth,

NOW THEREFORE, the parties hereto agree to amend the Agreement as follows:

1. Pursuant to Paragraph 10 of our Agreement dated July 18, 2011 between the Trustees of Columbia University in the City of New York and Academy Express, LLC (hereinafter the "Agreement"), Columbia hereby elects to renew this Agreement for an additional six (6) year term, with an option to renew for an additional four (4) years. The Term shall be effective from July 1, 2017 through June 30, 2023.

In cases of interruptions or changes in shuttle service, alerts will be displayed here on the Transportation site to keep you informed.



# Reduced Shuttle Bus Service and Modified Spring Schedules

April 06, 2020

As University operations have shifted in response to public health directives, Columbia Transportation will reduce shuttle bus service to be in line with current ridership.

### Lamont Shuttle:

- Effective immediately, the Lamont shuttle is out of service.

### GWB/Fort Lee Shuttle:

- Beginning **Monday, April 6**, the [GWB/Fort Lee shuttle](#) will run on a full day schedule.
  - The Academy branded bus (8:30 AM Fort Lee departure, 5:08 PM CUIMC departure) will be canceled.
- Beginning **Monday, April 13**, a new schedule will take effect.

### Manhattanville Loop Shuttle:

# Summer Schedule for Intercampus Shuttle Beginning May 18

May 11, 2020

The Intercampus Shuttle summer schedule will begin on Monday, May 18. The last day of the Academic Year schedule will be Friday, May 15.

Changes include:

- The 157th Street stop has been eliminated due to the reopening of the 168th Street 1 Train.
- The 2,3 MTA station at 125th Street has been added to the AM and PM schedule.
  - 2,3 Train AM stop: 105 W 125th Street (in front of Staples)
  - 2,3 Train PM stop: 72 W 125th Street (in front of Chipotle)
- Other seasonal changes to stop times consistent with summer operations.

## Operational Changes and Safety Measures During COVID-19

Columbia Transportation is working with our shuttle provider, Academy Bus; our black car service provider, Luxury; and our Evening Shuttle partner, Via, to update cleaning and safety protocols in light of COVID-19.

June 01, 2020

### University Shuttle Buses

Following the measures recommended by experts and implemented by the MTA and NJ Transit, Academy [cleans and disinfects the buses daily](#) [↗](#), paying special attention to high-touch areas. A hand sanitizer dispenser and wipe dispenser have been added to each of the shuttles. COVID-19 fact sheet signage has been placed at the shuttle stops.

In accordance with [Executive Order 202.18](#) [↗](#), any person utilizing public or private transportation carriers or other for-hire vehicles who is over age two and able to medically tolerate a face covering must wear a face covering over the nose and mouth during any such trip. Phone calls are not permitted on the shuttle buses as talking in enclosed spaces can spread the virus.

Columbia Transportation asks that passengers maintain at least one empty seat between them and the next passenger on buses. Passengers should maintain at least a 6-foot distance between them while waiting at the stops and boarding the shuttle.

As an additional step, starting June 3, the passenger limit on our vehicles will be 50% of posted capacity, including standees. On the Intercampus, Lamont and Ft. Lee shuttles this will be a maximum of 34 riders. This will allow passengers to maintain distance from one another when riding our shuttles. When a shuttle reaches capacity, the driver will notify you. You may choose to wait for the next shuttle (if available) or utilize public transportation as an alternative.

### Black Car Service

State-mandated physical distancing rules require drivers and passengers to wear face coverings. When possible, the driver and passenger should maintain at least six feet of distance between them. Only passengers from same party can share a vehicle; otherwise, all rides must be limited to one passenger. Ventilation in the car will be set to non-recirculated air and drivers will keep windows down where possible.

In addition to only offering Private rides in accordance with physical distancing policy, Via has implemented a multi-faceted safety approach including:

- Enhanced daily cleaning protocols with EPA approved disinfectants
- Via HQ assisting Driver Partners in equipping vehicles with materials for regular disinfection
- Six feet of social distance and/or a partition will divide those in the vehicle
- In NYC, riders and drivers must wear face coverings when in vehicle, even if socially distant
- Drivers encouraged to enhance ventilation in the vehicle through the opening of windows
- Drivers must self-monitor for temperature and symptoms before each shift
- Riders and Drivers must each self-certify via the App that they are symptom-free and have not had a likely exposure

Via is further supporting the safety of Riders and Drivers by supplying Driver Partners with personal protective equipment (PPE) and cleaning supplies free of charge and providing assistance with partitions and supplemental professional cleanings.







# What is the community shuttle?



Columbia University provides free bus shuttle service for the community, M-F, 9 a.m.-5 p.m.

Shuttle service runs year-round, with a more limited schedule in the summer.

## Who can use the shuttle?



The shuttle is wheelchair accessible and free for people with disabilities, the elderly and their companions, as well as individuals with service animals.

## How do I identify the shuttle?





# Red, Green, or Blue?




During the Academic year, the route is serviced by three shuttle buses designated as Red, Green, and Blue. You'll see these colors used on the shuttle map on page 6 and the shuttle timetables on pages 9-15.

You can tell which bus is at your stop from the display on the front of the bus. During the summer, the route is serviced by one bus without any color designation.

## Do I need an ID to ride the shuttle?

All riders must present a valid ID upon boarding the shuttle. Accepted IDs:




