This letter serves as an amendment to the letters dated September 28, 2017 and September 4, 2018, to include the additional spaces on the Manhattanville Campus that are now being provided wireless internet access.

Columbia University Information Technology has successfully installed and will continue to maintain wireless internet access in the following areas of the Manhattanville Campus:

As of September 2017

- Jerome L. Greene Science Center
- Lenfest Center for the Arts
- Small Square Open Space (also known as The Plaza)

As of September 2018

- University Forum
- The Grove Open Space

As of December 2021

- Columbia Business School – Henry R. Kravis Hall
- Columbia Business School – David Geffen Hall
- Large Square Open Space (also known as The Square)

It continues to be CUIT's understanding, based on conversations between CU Facilities (MDG) and NYC Parks, that the West Harlem Piers Park remains covered with free WiFi under an agreement between the NYC Parks and Time Warner Cable (now Spectrum). Accordingly, CUIT considers the obligation to provide free WiFi in West Harlem Piers Park to be satisfied.



Re: Columbia University Manhattanville Academic Mixed-Use Development: Wireless Internet Access pursuant to Section 5.07(a)(i) of the Declaration of Covenants and Restrictions, by The Trustees of Columbia University in the City of New York, dated as of December 14, 2011

“Declarant shall provide free wireless internet access within portions of the Open Space at the time such portions are Substantially Completed in accordance with Article IV, and, if feasible, to the West Harlem Piers Park. All access would continue for 25-years measured from commencement of providing full internet access to all Open Space. Declarant shall install and maintain appropriate signage at prominent locations in the Project Site’s Open Space that apprise the public of the availability of free wireless internet access.”

- The portions of Open Space that are currently Substantially Completed include the Small Square (also referred to as The Plaza), the Mid-Block Open Area between Sites 3 and 4, the Grove adjacent to Site 1, and the Large Square (also referred to as The Square). Free wireless internet access is available in these areas.
- Wireless internet access in West Harlem Piers Park is currently being provided by Spectrum/TWC per an agreement between the New York City Department of Parks and Recreation and TWC.
- Attached you will find photos of the signage that has been installed on the campus that informs the public of the availability of free wireless internet access in open spaces.

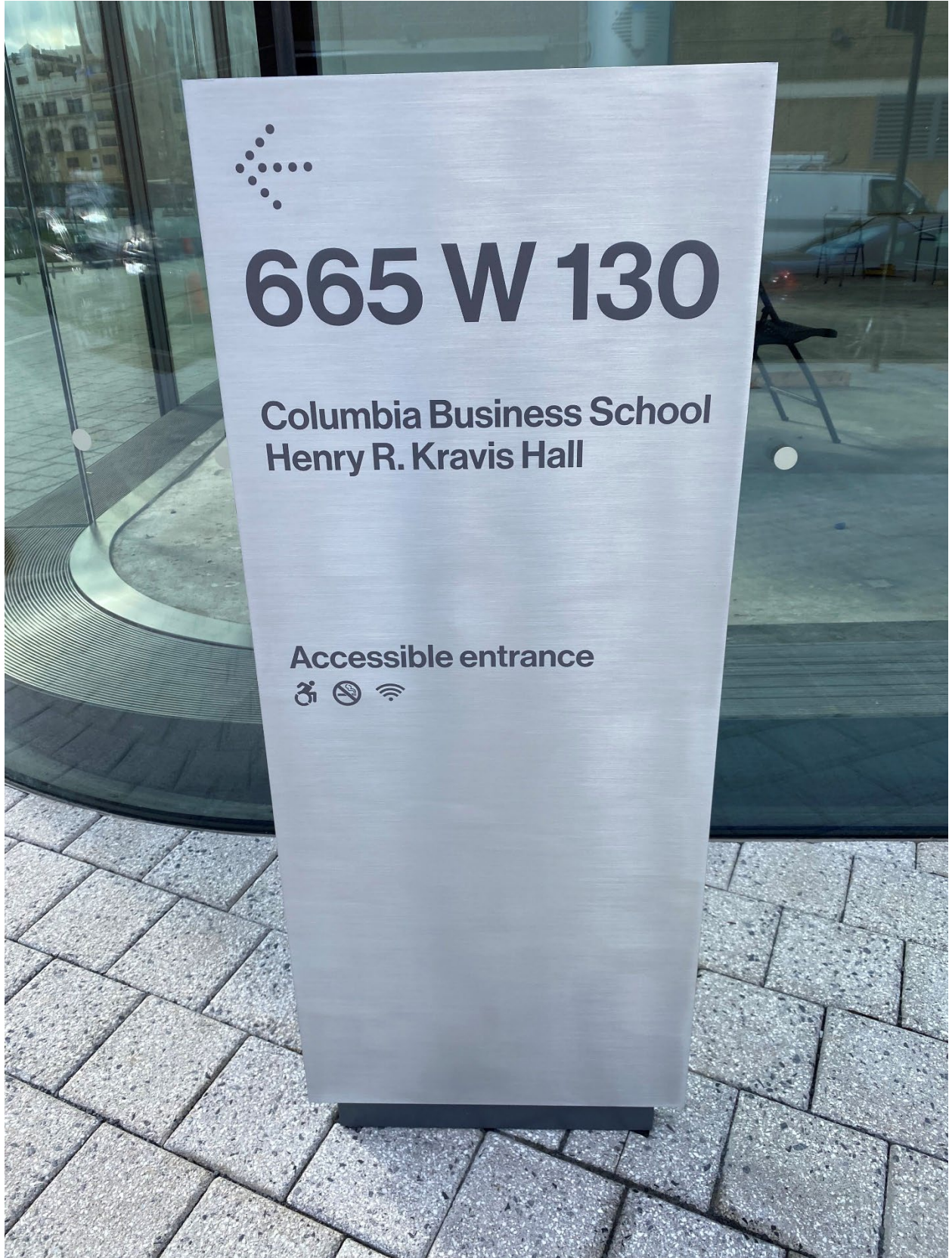

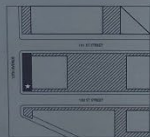

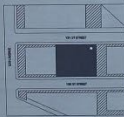
