MEET DDC DIRECTOR AND BRONXITE SASHA WELLS

For Sasha Wells—the newly minted Executive Director of Columbia’s Double Discovery Center (DDC)—eradicating the barriers around access to higher education is personal. Growing up in the South Bronx, she witnessed firsthand how socioeconomic inequities can shape the trajectory of a child’s educational path as well as how access to education and a robust support system can change someone’s trajectory.

With a background that allows her to relate to the students who come through the Double Discovery Center, and a personal understanding of the barriers and challenges faced by students in underserved communities, Wells is helping tackle current challenges like high school students’ mental health in the aftermath of the COVID-19 pandemic. As someone who personally experienced culture shock and struggled to access resources in a college setting, Wells knows intimately the importance of preparing students for college not just academically, but socially and emotionally, and the importance of support in breaking the cycle of intergenerational poverty.

PREP FOR COLLEGE WITH DOUBLE DISCOVERY



Since 1956, the Roger Lehcka Double Discovery Center has (DDC) helped increase high school and college graduation rates for low-income and first-generation college-bound youth. In its more than 50 years, DDC has worked with more than 15,000 young people. Around 90% of DDC participants graduate from high school on time and enter college the following fall.

Starting in 7th grade, students from select Manhattan public schools are eligible to apply for DDC programs, which focus on academic enrichment, college preparation, and mental health and resilience.

The deadline to apply for spring programs is January 6. Visit ddc.columbia.edu to learn more about eligibility, academic opportunities, and deadlines.

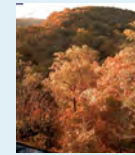

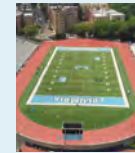

INDULGE YOUR CURIOSITY WITH FREE COURSE AUDITING

Looking for a way to keep your mind sharp this winter? If you live in Upper Manhattan including Randall's Island or the South Bronx, haven't recently attended high school, and aren't enrolled at a university, you're probably eligible for the free Manhattanville Auditing Program at Columbia.

Roy Byrd, a retired computer science researcher and Columbia neighbor, has participated in the Manhattanville Auditing Program since 2018. "Throughout my career, I always planned to 'move to a college town when I retire,' in order to remain intellectually vital and entertained," he said. "Living near Columbia helps me achieve that and the courses are part of the intellectual stimulation."

Auditors observe classes, but don't receive credit towards a degree. They also don't receive a grade or have to take exams or write papers. Manhattanville auditors have the opportunity to learn professional skills in marketing, accounting, and nonprofit management courses, or they can take a liberal arts approach and seek out classes in comparative literature, philosophy, and even biology and linguistics. The courses available to audit change every semester!

BECOME A MANHATTANVILLE AUDITOR



There are a few steps involved in becoming a Manhattanville Auditor. First, **fill out the online application** through the Columbia School of Professional Studies website by **December 15, 2022** to audit in Spring 2023. For this application, you'll need proof of residency, like a current utility bill, bank account statement, or residential lease.

Once you're accepted, you'll get information about setting up your university ID, registering for a class, and submitting your documentation to meet Columbia's immunization requirements. **Registration for auditors for the Spring 2023 starts on January 4, 2023.**

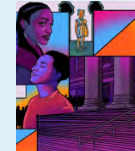

UPTOWN COMMUNITY GROUPS FOR ELDERLY

Uptown is home to a collective of neighborhood groups that are uplifting and spreading joy among our elders. Whether you're looking to connect with your neighbors or you're in search of fun-filled activities for your loved one, there are many offerings for senior citizens in Harlem and Washington Heights.

The **'Seniors AIM High'** program fosters community through fitness. The initiative—led by The Armory Foundation and Columbia University Irving Medical Center's Office of Community Service Programs—offers free weekly exercise sessions for 60+ adults in Washington Heights-Inwood, Harlem, and the South Bronx.

The nonprofit **Dances for a Variable Population** cultivates community through movement. The organization—a Columbia Community Service grantee—provides free, low-cost dance programming and theatrical performances throughout the city for all ages and abilities, with a focus on seniors.

The **ARC Senior Centers** provide safe spaces for elders to commune and connect. The centers—located in Central Harlem, West Harlem, and Washington Heights—are hubs for elder community activists, artists, community leaders, and veterans to participate in recreational activities.

SHUTTLE BUS SERVICE FOR ELDERLY & DISABLED



Columbia University provides a shuttle bus service free of charge to members of the local community who are disabled or who are senior citizens (including their attendants) via the ADA-accessible Intercampus Shuttle.

The shuttle bus connects the new Manhattanville campus with the Morningside campus (116th Street and Broadway) and the Columbia University Irving Medical Center (168th Street and Broadway), as well as the subway station at 96th Street and Broadway and Harlem Hospital (135th Street and Lenox Avenue). The shuttle bus service runs on a regular schedule on every weekday, except on state and federal public holidays.

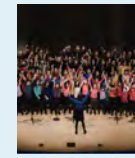

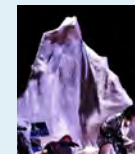

A Passion for Black History in Harlem

For Harlem native Carolyn D. Johnson, it's Uptown's historical flair that makes the community one of the most unique places on the globe.

"I like to tell people no place in the world has contributed more to American history and world history than Harlem," said Johnson. "We need to honor the individuals that have paved the way to make Harlem what it is."

Johnson's passion for Harlem's history led her to create her own local boutique tour company, Welcome to Harlem. Launched in 2004, Welcome

to Harlem offers in-person experiences exploring Harlem's rich past and cultural diversity and has inspired her other businesses, including the education-driven platform Harlem Roots and her latest creation, the Harlem Renaissance-inspired board game Harlem-Opoly.

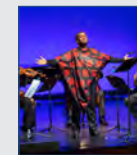

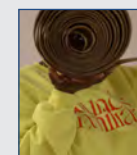

Stories From the Apollo Theater Oral History Project

It's no secret that the Apollo Theater is a legend in pop culture and music. But on its 75th anniversary, the Apollo set out to capture its own story. The Apollo Theater Oral History Project, which is available for public viewing at Columbia's Rare Book and Manuscript Library, recorded the theater's history through interviews with legends like Smokey Robinson; as well as managers; industry moguls; and many others.

The project was a collaborative effort. In the early 2000s, the Apollo reenvisioned itself as a renewed center for arts, music, and culture. This included

capturing its past in an oral history archive, with the support of the Columbia Center for Oral History. The archive's success inspired the theater to start a program to teach oral history to local students.

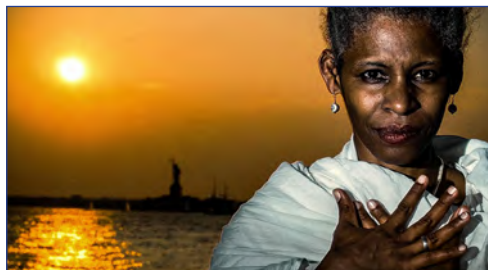

Josefina Báez: The Dominican-York Icon's Archive

Poet. Storyteller. Dancer. Dramatist. Writer. Teacher. Director. Performance Artist. These words just scratch the surface of Josefina Báez, the Dominican-York icon, whose archive was recently acquired by the Latino Arts and Activisms Collection and is available at the Rare Book and Manuscript Library.

Báez, who immigrated to New York from the Dominican Republic, has spent her artistic life transforming the inner and outer identities of migrants into public explorations of language, culture, and community. Upper Manhattan has been a key part of her work and has shown her work in Harlem, Washington Heights, and Inwood.

What to Know About the June 27 Primary

The June 27 primary is just around the corner—and it's an important one for local offices.

This time around, the New York City Council and other local offices—such as the district attorney—will be on your ballots. Although council members typically hold their seats for four years, they are now facing reelection just two years into their term due to City Council redistricting.

Columbia Neighbors compiled a voting resource where you can find everything you need to know to make your voice heard in the June 27 primary, including information on early voting, absentee

ballots, polling places, and how you can find out who represents your district.

Some key dates to remember include: the deadline to update your address (**June 7**), the last day to request an absentee ballot (**June 12**), and the last day to register to vote in the June primary (**June 17**).

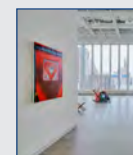

How to Access Free ESOL Classes at Columbia

Community Impact, the University's largest student service organization, offers free English classes for adult immigrants who live in the New York City area.

Every year, Community Impact offers three free 12-week cycles of English for Speakers of Other Languages (ESOL) courses across six levels from beginning to advanced literacy. There are also conversation courses offered for higher levels of the program.

Important things to note: courses are offered in the Fall (September through December), Spring

(January through May), and Summer (June through August); you must be 18 years or older and live in New York City to enroll; classes are free, but students are expected to buy the textbook.

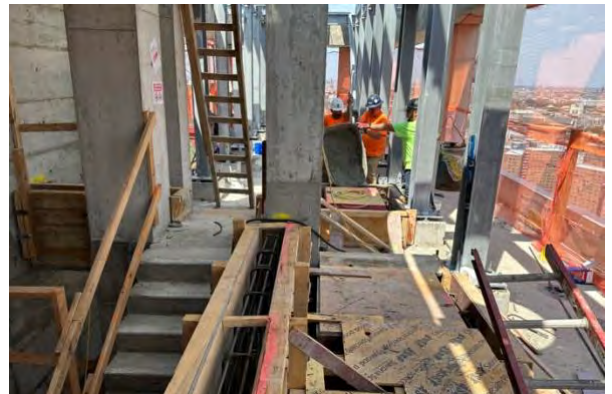
